HOLE-IN-ONE RULES AND CONDITIONS

- **QUOTED PREMIUM MUST BE PAID IN FULL PRIOR TO THE DAY OF THE EVENT.** UPON RECEIPT OF PREMIUM, NJ CAR SERVICES, INC. WILL ISSUE A CONFIRMATION OF INSURANCE COVERAGE. CERTIFICATE WILL BE EMAILED/FAXED DIRECTLY TO THE DEALERSHIP.
- WITNESSES MUST BE 18 YEARS OF AGE OR OLDER. IT IS THE RESPONSIBILITY OF THE DEALERSHIP INDICATED ON THE APPLICATION AND THE TOURNAMENT DIRECTOR TO PROVIDE WITNESSES. THE FOLLOWING WITNESS PROVISIONS MUST BE ADHERED TO:
 - ♦ IF THE VEHICLE PRIZE VALUE IS **OVER \$25,000**, YOU MUST PROVIDE TWO (2) WITNESSES. IF THE VEHICLE PRIZE VALUE IS **LESS THAN OR EQUAL TO \$25,000**, YOU ARE REQUIRED TO PROVIDE ONE (1) WITNESS ONLY. WITNESSES **CANNOT** PARTICIPATE IN THE TOURNAMENT.
