Execute Power of Attorney form to obtain title in dealership's name	Y
Obtain authorization from customer to pay off lien (if vehicle was financed)	Y
Obtain authorization to use vehicle as a trade (if not owned by purchaser)	>
Complete application for replacement title (if title to trade vehicle is "lost")	Y
Deliver authorization for loan pay-off and payment of balance to lienholder	>
Deliver required documents to NJMVC/DSP to obtain title in dealership's name	>
